**FOR FOUR YEARS OLD AND UPWARD** By subscription of \$100 each which should accompany the nomination, \$500 to pass the entry box and \$500 additional to start with \$100,000 guaranteed and an additional \$50,000 from the Breeders' Cup Fund for Cup nominees only. The host association's monies to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. Breeders' Cup Fund monies also correspondingly divided provided a Breeders' Cup nominee has finished in an awarded position. Any Breeders' Cup Fund monies not awarded will revert back to the Fund. Weight: 122 lbs. Non-winners of \$25,000 at one mile or over on the turf since October 31, 2009 2 lbs.; \$20,000 at one mile or over since then, 4 lbs.; \$10,200 at one mile or over since September 30, 2009, 6 lbs. (Maiden, Claiming and Starter races not considered in estimating weight allowances). Starters and riders to be named through the entry box by the usual time of closing. This field will be limited to twelve starters. In the event more than twelve pass through the entry box, the twelve starters will be determined at that time with preference given to Grade I, II or III Stakes winners in that order, then those that have accumulated the highest turf earnings in 2009-10. Preference to Breeders' Cup nominees of equal racing quality. For those that enter and are eliminated under these conditions, the nomination and entry fees will be refunded. Trophy to winning owner given by Breeders' Cup Ltd. SUPPLEMENTARY NOMINATIONS OF \$3000 EACH (which include entry and starting fees) CLOSE WEDNESDAY, FEBRUARY 17, 2010 BY THE USUAL TIME OF CLOSING.
