After reviewing the video and talking to the Jockey's, the Stewards determined the #6 Iconic Rock, with Jockey Henderson Gonzalez did come in causing #1 Skylane, with Jockey Charlie Marquez, to check his mount costing position, near the eighth pole. Therefore #6 was disqualified from second and placed fourth behind #1, then made the race official.</p>
